NEW PROCEDURES IN CERTIFICATION

Readiness consultations may be done in a center at times other than when the Certification Committee meets if **1)** serious consideration is given as to whether or not it is in the best interest of the aspirant to be treated special, **2)** the consultation review is approved by Certification Chair, Charles Berger, and by Bill Baugh, who is serving as the "southern representative of the certification chair," **3)** one member of the certification committee sits on that consultation review, **4)** the members on that review are new to the aspirant, **5)** a written Presenter's Report and a Committee Action Report will be sent to the Certification Chairperson, and **6)** all expenses incurred will be paid by the center requesting the review.
