SERACPE MEETING IN TAMPA

More than seventy members attended the regional meeting during the ACPE Annual Conference in Tampa on November 17, 2006.

Chairperson Dan McRight convened the gathering. Members who had not previously attended a regional meeting introduced themselves and were welcomed.

Charles Berger, outgoing chair of the regional certification committee, presented the newly certified supervisors: **Dean Luther (Anderson, SC), Ramona Reynolds (Orlando, FL), and Cristina Stevens (Pensacola, FL); and a new Associate Supervisor, Ty Crowe (Jacksonville, FL).**

Jap Keith, Regional Director, provided information about the upcoming REM Invitational, deadlines for meeting with the Certification Committee in the spring '07, and a summary of the regional meeting to be held at the Buccaneer Beach Resort on Jekyll Island, GA, March 20-24, 2007. He also noted changes occurring among personnel within the region (noted on page 2 of this Newsletter). He gave a brief report on the research completed in the summer of 2006 regarding the units of CPE, the categories of persons engaged, and the requirements of CPE by seminaries. He noted that the Administrative Board had requested him to do a similar questionnaire for the fall unit, and he gave a report on the data received thus far. As Treasurer, he gave a report on income and expenses through November 15 and made a favorable comparison with the budget year 2005.

Peter Keese, SERACPE Representative to the ACPE Board of Representatives, informed the region that the annual continuing education meeting of the ACPE, Inc. will move from the fall to the spring in 2009 so that ACPE can meet at the same time that some other cognate groups will be meeting. The place is projected to be in Orlando, FL. in late February or March. (This means that the

ACPE, Inc. will meet in November '08 in Richmond, VA, that an REM Invitational will meet in early February '09, the ACPE Conference late February or early spring '09; and, therefore, the SERACPE regional meeting will have to be scheduled either in late March or in the fall of '09.)

Appreciation was expressed for the creativity and labor of the members of the SERACPE who comprised the ACPE Conference Planning Committee: Bill Baugh, Chair, John Galloway, Amy Greene, Olen Grubbs, Irene Henderson, Jap Keith, Wes Monfalcone and Larry Wagoner.
