Report from Accreditation Committee by Wayne Maberry

The following centers have reviews in 2012:

Five Year Reviews (cf. Accreditation Manual, pages 39-40): Atlanta VAMC; St. Thomas/Nashville CPE Partnership).

Ten Year Reviews (cf. Accreditation Manual, pages 41-42): Baptist Health (Pensacola); Bon Secours/Roper and St. Francis Hospital (postponed from 2011 to 2012); VAMC at Memphis; Johnson City Medical Center; Spartanburg Regional Medical Center; Tampa General Hospital; VITAS Innovative Hospice Care.

All ten year reviews need to take place before the middle of November.

Completing Appendix 3 (see page 64 in the Accreditation Manual) is the initial step for both the five and ten year reviews.

Summary of the Treasurer's Report

As of December 31, 2011 the region has received **\$168, 808** (the largest portion of which was \$131,307 in student unit fees). \$12,000 was transferred from Endowment into the Operating Budget to cover the expenses of "special projects." We expended **\$126,762** toward operations, transferred \$40,000 from operating to a CMA account, and ended the year with a balance of \$2,881.92.

On December 31, we had an operating checking balance of \$36,839, a cash reserve balance of \$120,663, and an Endowment Fund balance of \$168,192 for a total of **\$325,694**.

A detailed line item accounting of the operating budget can be found on our website, *seracpe.org*, in the monthly Treasurer's Report.
