GOING FORWARD:

I want to repeat some comments from the last Newsletter because I want to encourage your becoming a conversation partner in envisioning our life together for the next fifty years..

ACPE, Inc. is a **legal entity**. We were first incorporated by the State of Massachusetts. When the Office was moved to Decatur, GA, we were incorporated by the State of Georgia.

ACPE, Inc. is a **unified financial entity**. From the beginning we attained the tax exempt status of a 501c-3 professional education organization. Annually, the ACPE, Inc. files financial records with the IRS that includes all regional and the national revenue and expenses. In 2014 a unified certified audit of all funds in all checking and investment accounts were compiled for the ACPE Board of Directors at its May, 2015 meeting. From henceforth, monthly financial records of each region will be filed with the ACPE Office so that the annual certified audit can be completed quicker, less expensively, and more accurately. This action of our Board of Directors ensures accountability, collaboration and cooperation of our unified financial records.

The ACPE, Inc. is a **professional educational entity** recognized by the U.S. Department of Education as an accrediting agency for programs of specialized education. We are the only body providing CPE that is so recognized. We will continue reforming Standards, revising Accreditation and Certification procedures, and envisioning our position/practices within the international community. And, we will continue being recognized as the “accrediting agency” for ACPE Certified Programs of CPE.

In the coming year we will envision an **“Organization Design”** for the early decades of the 21st century. We have responded to two surveys (perhaps more will be coming to you). The Board of Directors employed the services of a consulting firm who will quickly engage our membership in a feasibility study about how we might best go forward. The members will dialogue, discuss, and debate ideas and perspectives at the ACPE conference in Denver in 2016. Hopefully, some actions will be taken by the membership in Denver that will form and ensure our future work. To the degree that happens, 2017 will be a year of implementing actions taken by the members in Denver. In 2017, we will celebrate Fifty Years of the ACPE, Inc.

This is a most exciting time of envisioning and transitioning into the future that will be given to us. It is a time for critical reflecting on what has been and hopeful anticipation of what might be. Please: enter the process and give it your best thoughts and prayers.

Going forward, how might we better organize the ways in which we do our primary work of accrediting centers; marketing our programs of CPE; recruiting/educating/certifying student units; supporting programs for SESs and certifying Supervisors of CPE; providing continuing professional development; completing peer reviews; staffing our Office; securing our revenue and paying our expenses; caring for our colleagues; celebrating our life together; and endowing future development by increasing the corpus of the FCPE? Perhaps you can envision other dimensions of our work and life together that might be better organized. Let’s devote energy and effort for our common welfare! Jap
